 - In relation to students who have learning support needs e.g. English not being their first language, it is recommended that student support would be an appropriate means to alleviate any challenges and provide parity. A PLSP might be appropriate. If there is an issue then this would offer a fair and formal support for the student and guidance for the assessor.
 - In relation to recording timings, it is recommended that the cover sheet for normal assessments include a section relating to this (the area noting the word count should be adapted), completed by the assessor in the same way as a Viva is recorded.
